By virtue of Section 4 of the SFA, Kwan Chee Seng is deemed interested in 56,660,756 shares held by Luminor Pacific Fund 1 Ltd. and 44,514,009 shares held by Luminor Pacific Fund 2 Ltd.. Starland Holdings Limited is a 83.2%-owned subsidiary of GRP Chongqing Land Pte. Ltd., a wholly-owned subsidiary of GRP Land Pte. Ltd. which is in turn wholly-owned by GRP Limited. Kwan Chee Seng has a shareholding interest of 32.5% in GRP Limited. By virtue of Section 7 of the Companies Act, Kwan Chee Seng is deemed to be interested in the 6,547,324 shares held by Starland Holdings Limited.
